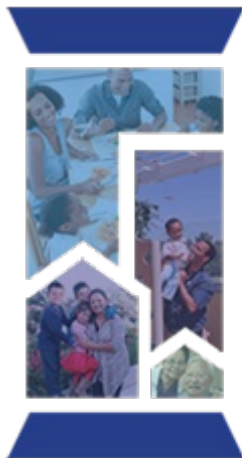

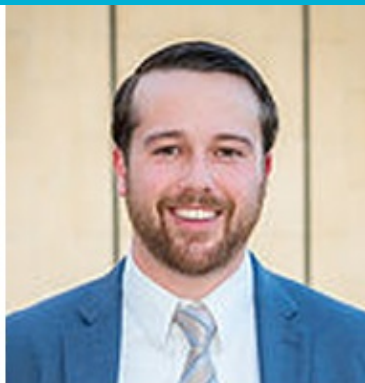
LISC San Diego Sponsored Roundtable Presents: Legislative Updates from Sacramento
